

Terms and Conditions – New Idea Puzzles (2017/2018 – Issues 1- 27)

General

12. The winners' will be notified by mail and names of all winners will be published in New Idea magazine on-sale [refer to date schedule at clause 11] respectively.
13. Prizes will be sent within 28 days of being published.
14.
