

Terms and Conditions – New Idea Puzzles (2019 – Issues 28- 52)

General

1. Information on how to enter and prizes form part of the Terms and Conditions. Entry into this competition deems acceptance of these Terms and Conditions.

14. The winners' will be notified by mail and names of all winners will be published in New Idea magazine on-sale [refer to date schedule at Clause 13] respectively.
