

Terms and Conditions – New Idea Puzzles (2020 – Issues 1-26)

General

1. Information on how to enter and prizes form part of the Terms and Conditions. Entry into this competition deems acceptance of these Terms and Conditions.

15. Prizes will be sent within 6 weeks of being published.
16. Prize on offer

17. **Total competition prize value is \$26,000 as of 12/11/19.**
18. Total prize value is \$1,000 each week, in **26 weekly draws**. Each weekly draw comprises of **6 x \$100 cash and 8 x \$50 cash**.
